GENERAL INFORMATION

Growforce K-Yield is specifically formulated for foliar delivery of Boron, Copper, Manganese, Molybdenum, and Zinc.

Growforce K-Yield can also be used for in-furrow applications.

RATE RECOMMENDATIONS

Field, Row, Vegetable and Vine Crops: Apply 1-3 quarts per acre per application throughout the growing season. More frequent applications at 1 pint per acre may be needed to correct deficiencies once they occur.

Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, plant species and general health. For best results, follow soil/tissue test recommendation.

MIXING AND HANDLING INSTRUCTIONS

Growforce K-Yield is compatible with a wide range of commonly used agricultural chemicals. When mixing with other chemicals, always mix a small quantity and check for precipitate (fall out) in the mixture. If precipitation occurs, DO NOT proceed with application.

If the mixture does not precipitate and it's the first time you have used this combination of products, test a small area of the crop prior to treatment of the whole crop.
